Hands-On: Participants will use a provided template to classify an example AI system as High-Risk, Medium, or Low, determining the immediate mandatory controls required by the EU AI Act.
9 June	CSDDD/NIS 2: Unifying the Vendor Audit	Supply Chain Accountability	Objective: Provide a unified audit checklist for critical suppliers that simultaneously satisfies the human rights demands of CSDDD and the cyber security demands of NIS 2. Hands-On: Development of 5 mandatory contract clauses that cover both ethical labor standards and the NIS 2 24-hour incident reporting requirement.
25 June	Data Sovereignty Playbook: The Investigation Quick-Launch	Cross-Border Data Transfer	Objective: Create a Pre-Approved Data Transfer Protocol to prevent investigations from stalling due to data localization laws (e.g., China/India). Hands-On: Attendees will map a fictional data transfer (e.g., HR data from Shanghai to London) and identify the specific legal mechanism and encryption standard required to keep the investigation moving.
30 July	Whistleblower Intake & Triage: Meeting the 7- Day Deadline	Investigations & Whistleblowing	Objective: Operationalize the strict intake and feedback timelines of the EU Whistleblowing Directive and ensure non-retaliation. Hands-On: Live simulation of

			receiving a complex report. Participants will draft the mandatory 7-day acknowledgment letter and practice the initial triage steps to determine if it's an internal-only issue or requires immediate external reporting.
27 August	ESG Incident Response: The Human Rights Escalation	NEW: ESG & CSDDD	Objective: Define and implement the internal escalation process for a confirmed ESG/Human Rights violation (e.g., a modern slavery finding in the supply chain) under the CSDDD framework. Hands-On: Participants will use a case study to define the mandatory Remedial Action Plan—distinguishing between an acceptable CSDDD response and a simple "clean up" that will fail regulatory scrutiny.
